CSRC DOCTRINE

Page 1

As a Certified Subconscious Restructuring[®] Life Coach/Counselor (CSRC) I agree to adhere to the following Ethics and Standards set forth by the Subconscious Restructuring[®] Institute.

- 1) I fully understand the SR[®] Process is **NOT** psychotherapy, it is a **Program Process**. I will always make this perfectly clear to my clients by providing them with the CSRC - Client Agreement.
- 2) The CSRC does not dictate to a client. The CSRC is trained to empower their clients to make decisions that work the best for them. The CSRC may give the client a recommendation if asked or the CSRC may ask the client if he or she would like a recommendation. The CSRC will never give a recommendation without first being asked or by asking the client.
- 3) Should I integrate other modalities into SR[®] session I will notify the client of this and inform them of which modalities other than SR[®] that I will use.
- 4) Should I integrate other modalities into an SR[®] session without informing the client I will be subject to the possible loss of my SR[®] Certification.
- 5) Prior to an initial session I will make sure my client fully understands the process of Subconscious Restructuring[®], the bounds of confidentiality, financial arrangements and other terms of the CSRC - Client Agreement.
- 6) I will accurately identify my qualifications and experience.
- 7) I will never mislead or make false claims about what my client will receive from me or the coaching/counseling process.
- 8) I will respect the client's right to terminate my services at any point of the process.
- 9) If I believe the client would be better served by another counselor, life coach, or by another resource, I will encourage the client to make a change.
- 10) I will suggest my clients seek the services of other professionals when deemed appropriate or necessary.
- 11) I will take all reasonable steps to notify the appropriate authorities in the event a client discloses an intention to endanger self or others.

- 12)** I will respect the confidentiality of my client's information, except as otherwise authorized by my client, or as required by law.
- 13)** Whenever a third party is used to process the data of a study I will make sure that all personal information is removed from the data collection.
- 14)** I will obtain an agreement from my clients before releasing their name as clients or references, or any other client identifying information.
- 15)** I will not sell or release my client's phone, email, home address or any other personal information without the approval of the client.
- 16)** The Emotional Checklists and the Step 7 CD are provided to the CSRC as part of their marketing package and the CSRC is free to print or copy as they see fit. Every CSRC will be licensed to copy as many of the "Subconscious Restructuring®" Workbook for Adults, Ages 7-17 and Warriors as they need for their clients only. No one has the right to distribute the PDF version of these documents except the SR® Institute.
- 17)** The CSRC Guidelines are exclusive to the CSRC and may not be distributed to anyone other than another CSRC or MSRC.
- 18)** If I choose not to adhere to occasional updates to this document I have the option of relinquishing my Certification.
- 19)** I will not become sexually involved with any of my clients.
